

# REPRESENTATION AGREEMENT

Between

And

ANG MARKETS LTD.

**IT IS HEREBY AGREED THAT:**

**1 The Appointment**

1.1 It is agreed that ANG MARKETS LTD. appoints the Representative \_\_\_\_\_ to present the interests, company services and programs of ANG MARKETS LTD.

**2 Term of the Agreement**

2.1 This agreement shall continue for three years unless terminated as provided below.  
2.2 This agreement may be terminated after one year by either party giving the other three calendar months notice in writing. In the event of such termination, payment of any commissions due The Representative will be made following normal procedures outlined in this agreement.

**3 Scope of the Agreement**

3.1 The Representative is appointed to supply the following:  
3.1.1 Information and assistance to potential clients/buyers/sellers/investors wishing participate in ANG MARKETS LTD programs and company services.  
3.1.3 Information about the company and opportunities with ANG MARKETS LTD.  
3.2 This agreement gives The Representative no authority to enter into agreements on behalf of ANG MARKETS LTD.

**4 The Representatives Responsibilities**

4.1 The Representative agrees to:  
4.1.1 Adhere to and follow the ANG MARKETS LTD. Representatives Code of Practice.  
4.1.2 To keep ANG MARKETS LTD. fully informed of prospective customer's relationship that might affect ANG MARKETS LTD.  
4.1.3 Use their professional endeavors representing company services and programs to prospective customers.  
4.1.4 Use their professional endeavors to represent the best interests of ANG MARKETS LTD. and maintain its good reputation.  
4.1.5 Assist ANG MARKETS LTD. in other matters as shall be agreed between the parties.  
4.1.6 Provide ANG MARKETS LTD. with certified evidence that they are trading legally.  
4.1.7 A certified photocopy of their company documents.  
4.1.8 Maintain and inform ANG MARKETS LTD. of an accurate and adequate bank account, postal address, telephone and fax numbers and e-mail address.

## **5 Marketing and Promotion**

5.1 ANG MARKETS LTD. will Endeavour to provide relevant, adequate, and accurate information to The Representative about company services and programs.

5.2 The Representative shall not undertake advertising or publicity on behalf of ANG MARKETS LTD. or any of ANG MARKETS LTD.'s subsidiaries, partners or validating organizations without the prior written permission of ANG MARKETS LTD.

5.3 The Representative shall submit copies of proposed advertisements and publicity materials to ANG MARKETS LTD. for approval. Following approval by ANG MARKETS LTD., such materials may be passed to the any appropriate partner or validating organization for further approval.

5.4 All advertisements submitted under this agreement must have prior approval.

5.5 ANG MARKETS LTD. actively promotes their company services and programs through its web site and other means of electronic recruitment. ANG MARKETS LTD. may refer leads to The Representative from these sources.

## **6 Representations and Competition**

6.1 The Representative shall not solicit the customers of ANG MARKETS LTD.

6.2 The Representative shall disclose agreements entered into establishments, companies and institutions competing with ANG MARKETS LTD.

## **7 Confidentiality**

7.1 The Representative agrees to abide by the terms of the ANG MARKETS LTD. Confidentiality.

## **8 Commission**

8.1 In consideration for services rendered by The Representative under this agreement, ANG MARKETS LTD. agrees to pay the Representative commissions based on the Fee Protection Agreement

8.2 Commission will be paid to The Representative on the basis of fees actually received by ANG MARKETS LTD.

## **9 Legal Jurisdictions**

9.1 The construction, validity and performance of this agreement shall be governed in all respects by the Laws of Hong Kong and procedures of ANG MARKETS LTD. and The Representative agree to submit to the Jurisdiction of the Courts of Hong Kong.
